1. Application for Street Use Permit June 23rd 8:00 a.m. to June 26th 6:00 p.m. for all of Crosscut, all of Wall St., All of Broadway (Lane for emergency vehicles included) alley way East of Associated Bank, Associated Bank Parking Lot for approximately 15,000-20,000 people for the 21st Annual Ellsworth Cheese Curd Festival: **MSC Borner/Steele** to approve this application. **Unanimous.** Police Chief Ladwig and the committee discussed utilizing different barricades for the main point access of the event. The committee also discussed security at the event with Police Chief Ladwig and representatives from the Cheese Curd Festival.
2. Ordinance #696 extending ATV and UTV routes to all Village roads: **MSC Steele/Borner** to adopt Ordinance 696. **Unanimous.** Police Chief Ladwig raised the concern with ensuring that law enforcement can enforce with proper wording.
3. Adding crosswalk flags at the intersection of Main St. and Plum St. with D.O.T. approval: **MSC Steele/Borner** to add **Unanimous.**
4. North Grant Street speed reducing measures and/or placement of new signs: No new action taken by the committee.
