COMMITTEE REPORTS/RECOMMENDATIONS:

Water and Sewer:

Trustee Curt Wandmacher reported on the annual Biosolid attended in Roberts on 11/21. Building is 100% full due to weather issues. Looking at a new dryer which will help reduce the amount of product and odor reduction. Members agreement extension discussed, looking at 15 years to 2040. Non-members was discussed, making up 20% of usage and whether or not they want new non-members. Village engineers are looking at the Village's treatment plant to see if the Village could take the extra centrate, possibly doing a pilot test. Besides transportation being an issue, other issue is PFAS, an emerging contaminant, chemical that has been linked to thyroid disease, decreased female fertility and cancer. Chemical is found in a variety of products including firefighting foam and non-stick cookware. WRWA is waiting for the DNR to develop surface water standards for the chemicals before testing. PWD Greg Engeset elected to a 5-year term as commissioner.

MSC Steele/Gulbranson to approve report. Unanimous.

Salary & Labor: 11/6 Trustee Neil Gulbranson

MSC Steele/Austin to give the committee the authority to negotiate and finalize the Police Union Contract, 2020 non-union wages and benefits, health insurance plan design and employee contribution, dental and life/STD/AD&D insurance plan renewal for 2020. Unanimous.

Parks, Recreation, Development: 12/2 Trustee Rick Sweig

Meeting with individuals requesting a Dog Park in Ellsworth. Buena Farrell passed out information they put together. Neil Gulbranson voiced concerns he had gotten in regard to a pop-up Dog Park at Crossing Meadows near the water tower, stating he is not against a Dog Park, but suggested other locations be looked at, possibly along Cty Rd C near East Business Way, off-street parking would be needed. Area will be looked at. No action taken.

Public Safety:

Ambulance Operating Committee - Board Rep. Dick Hines reported they have had several meetings, with more meetings planned, going over providers with the need to finalize before end of Dec.

Ellsworth Fire Services Assoc. Temporary Class "B" Retailer's License for Annual Chicken Feed Fundraiser 3/28/20:

MSC Sweig/Wandmacher to grant license allowing 20 and under on the premise. Unanimous.

Community Development Authority: 11/11 Trustee Curt Wandmacher

Paul Bauer gave an update on East End Development and updates on any future projects. He explained futures plans for expansion at the Ellsworth Creamery and the need for additional parking. PCEDC Director Joe Folsom discussed LMI surveys, noting the whole Village does not need to be done, random sampling can be done, State provides the samples to be used. Next meeting 12/9, 5 p.m.

Chief of Police:

-Nov.; 278 service calls, 85 traffic stops, 12 citations, 13 arrests including 2 probation and 2 OWI's

Trustee Wandmacher suggested the board look at walks/runs held in the Village as they are using the street versus sidewalks, felt someone could get hit. Chief Ladwig informed him they try to keep them off the roadways, Police are involved to some extent.
