Loberg stated that adverse possession comes into play, going back 20 years or more, title insurance does not cover adverse possession. GIS maps are a guide, not a survey of the property. To resolve the issue, start with a survey, all do deeds to correct the legal issues with all property owners involved and property owners sign the deeds. He has dealt with this in other areas of the Village and other communities. Village Board has no involvement.
